## EUSAIR Facility Point project: supporting EUSAIR governance

- The EU Strategy for the Adriatic and Ionian Region (EUSAIR): adopted in 2014 (Project FP: 1.5.2016-31.8.2023)
- General objective: "To promote sustainable economic and social prosperity in the Region through growth and job creation by improving attractivness, competitivness, connectivity (while preserving environment and ensuring healthy and balanced marine and coastal ecosystems)"
- EUSAIR covers **ten countries** (4 EU Member States (Croatia, Greece, Italy, Slovenia) and 6 non-EU countries (Albania, Bosnia and Herzegovina, Montenegro, North Macedonia, San Marino, Serbia)).

## Innovation in FP project:

#### Within Actvity T1.2 (Deliverables):

- "Innovation **expert support** in each Pillar " (to align work of TSG on inn.)
- "Innovation as a **horizontal topic** on TSG Agenda" (to be discussed at least once in each TSG)
- "Innovation capacity building" ("Establishment of cooperation with S3 teams to develop harmonised internationalization")

#### Specific objectives on innovation in 2 Pillars:

- **Pillar 1:** "To promote research, innovation and business opportunities in blue economy sectors,…" (in all 3 Topics)
- **Pillar 4: One of 2 objectives was:** Improving the quality and innovation of tourism offer... (*In topic 2: Sustainable and responsible tourism management (innovation and quality*)

- <u>Pillar 3: Study on how to stimulate eco-innovation and Circular economy,</u> Circular Economy event in 2023 (BIH)
- Pillar 4: Three analysis created:
- Overview of innovative projects funded by the European funds
- Detailed analysis of 88 projects including innovation in sustainable tourism
- Report for policy recommendations


#### S3 Events: FP LP

## Motivation for inter- regional cooperation

#### WHY?

- Pooling resources in similar activities: <u>To reach economies of scale and</u> raise the efficiency and efficacy of innovation investment
- Exploiting complementarities in technological development and innovation
  - Horizontal complementarities (related variety)
  - Vertical complementarities (user-producer interaction)

### To sum up: Innovation in EUSAIR FP

- The topic of innovation has been **analysed/explored/also considered** in flagships
- Networks/coperations established (DG, JRC, MRS)
- (Smart ERA project: On digitalisation in rural areas (Associated partner))
- (DG MARE: S3 crucial for implementation of EC Communication on Sustainable Blue Economy)
- <u>However: A horizontal topic, diversified (information, effort, contacts)</u> (many opportunities and experts available, too little connected?).



#### IN THE FUTURE:

#### Innovation is key for EUSAIR!

- To strenghten the role of networks: Innovation ecosystems
- Better integrate S3 strategies and EUSAIR (Concrete **interregional/cross macro regional** cooperation/pilot projects)- key role of S3 in the future
- To involve industry/ SME's/regional authorities- cities more (Very good suggestions from MRS Week)
- Support creation of value chains (Circular Economy), clusters
- To capitalise on Interreg ADRION projects more
- "Innovation Secretariat" (coordinating, communicating, capacity building)

In essence: To be more constant, focused (on results), connected, operational




#### **INNOVATION IN OTHER MRS:**

- EUSDR: Innovation dealt with by PA 7 Knowledge Society, via the following actions: ACTION 1: To promote coordination of national, regional and EU funds to stimulate excellence in R&I, in research areas specific for Danube Region; ACTION 2: To promote participation of Danube countries in EU R&I Programmes, in particular in Horizon Europe; ACTION 3: To strengthen cooperation among universities, research organisations and SMEs in the Danube Region; ACTION 4: To increase awareness and visibility of science and innovation in the Danube Region; ACTION 5: To support exchange of information and experience sharing for the purpose of preparation of future strategic R&I documents applicable in the new programming period; ACTION 6: To promote horizontal cooperation in science and technology across all PAs and other MRS
- EUSBSR: Policy area (PA) dedicated to Innovation (Supporting flagships in project development), creating project applications.



## INNOVATION IN EUSAIR-Future:

- Revision of the EUSAIR Action Plan (And Strategy): Research and Innovation as a horizontal topic (and Capacity building and Enlargement), to include also Smart Specialisation more concretely (TSG members to define activities, meassures)
- However: Will this be enough for dedicated, constant work on (Research and) Innovation? (Suggestion: Working group on Innovation/Digitalisation/Circular Economy supporting Pillars/experts, trends, MRS- meeting on 2-3 months, cross Pillar?)
